**CLOSING DATE for these tests is Wednesday, April 17, 2024, 5:00 PM, after which time entries cannot be accepted.**

**ENTRY FEE: TDX: TD \$50, TDX \$100 (US funds) which includes a \$0.50 AKC Recording Fee and a \$3.00 AKC Event Service Fee. Fees must accompany all entries. Make checks or money orders payable to IECC. Mail entries and fees to: Mavourneen Daspit, Test Secretary, 505 North Farr Road, Spokane Valley, WA 99206-3883. Only one AKC entry form will be accepted for each dog.**

**OWNERS** are responsible for errors in entry forms, regardless of who may make such errors.

All entries will be accepted until the official closing date. The DRAWING(S) will be held at Spokane Dog Training Club, 2620 N. Locust, Spokane, Washington, on April 17, 2024, at 5:30 p.m. to determine which entries will participate in the test. There will be two drawings. The first drawing will be random among those entries of COLLIES received, except that preference will be given to those COLLIES that have not previously earned a TD title for the TD test and to dogs that have not previously earned a TDX for the TDX test. Any entries not filled by collies will be determined by a second draw, which will be random among all entries of other breeds received, with preference given to those dogs that have not previously earned a TD title for the TD test and to dogs that have not previously earned a TDX title for the TDX test. All persons submitting entries are invited to attend the drawings.

When the advertised limit has been drawn, an ALTERNATE list will be drawn subject to the same preferences set forth above. The alternates will be advised of their positions on the alternate list and given an opportunity to be at the test site in case of absent dogs. Alternate entry fees will be refunded unless the alternate participates in the test. Entry fees will also be refunded to any confirmed entry that does not participate in the test, provided that the Test Secretary is notified prior to the day of the test and provided that an alternate entry participates in the test as a result of the withdrawal.

If the limit for entries is not reached in one test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged at the ratio of 2 TD equals 1 TDX.

**RESULTS OF THE DRAW** will be e-mailed, by noon of the day after the draw, to the e-mail address on their entry form. The Judging Program will also be e-mailed by the Test Secretary after the closing of entries. Should an acknowledgement not be received by the exhibitor within a reasonable time, please notify the Test Secretary by e-mail at [mdaspit@hotmail.com](mailto:mdaspit@hotmail.com) or phone at (509)991-8441.

**BITCHES IN SEASON** may participate. The Test Secretary must be notified that a bitch is in season prior to the drawing for tracks. These dogs will be given the last tracks and will not be allowed in the tracking area until just prior to running their tracks..

**THE TRACKING TEST SITE** ("Site") will open at 7:30 AM, April 28, 2024. The DRAWING FOR TD TRACKS will be at 8:00 AM. The TDX draw will be at 11:00 AM The first track will be run as soon thereafter as it has aged the proper length of time. In the event of any absentee(s) among the confirmed entries, the next alternate, in catalog order, who is present, will be allowed to fill the vacancy.

TRACKING COVER for the TD Test will be grassland of varying length on flat to gently rolling terrain with possible sagebrush. Possible cattle on site.

TRACKING COVER for the TDX Test will be on grassland of varying length, with rock outcrops, gravel roads, fences, trees, sagebrush and marshy areas, possibly cattle.

BY THEIR PRESENCE at the Site, all exhibitors and spectators agree to abide by AKC Rules and Regulations and to follow the instructions of the tracking test committee and judges. The Inland Empire Collie Club, the Tracking Test Committee, and the land owners assume no responsibility for any loss, damage or injury to any dog or person on the Site or loss, damage or injury to any dog or person traveling to or from the Site.

Dogs not actually competing will go where instructed and all dogs will be kept on LEASH. Owners are responsible for picking up after their dogs and for keeping the Site clean.

**AWARDS:** All competitors who pass this test will be awarded their tracking glove and a beer mug with an etched design by Eileen White.

**DIRECTIONS TO THE TRACKING SITE:** From I-90 take the Sprague exit (#245). West bound go left from the exit ramp, east bound turn right off the exit ramp. Go ¼ mile into Sprague and turn right at the corner by the Chevron station on 4th Street. Go a very short block and turn right again on "B" Street, and then go a couple blocks and turn right onto 1st Street. (For each of these turns you will be following the brown signs pointing to Columbia Basin Trails State Park). After the third right turn, go ¾ mile and watch for the tracking sign on the left side of the road. Turn left at the tracking sign, cross the railroad tracks and follow the gravel road through the gray gate and up the hill. **Use EXTREME care crossing the railroad tracks.** The staging area is ½ mile from the gate.

**We regret that we will not be hosting a shared group luncheon following our tracking event this year. Workers and exhibitors should bring their own drinking water, water for their dogs, and their own snacks and lunches. We will have plenty of room for participants to spread out and maintain a prudent distance from each other throughout the event. The nearest rest room facilities will be a five-minute drive away at the gas station in Sprague.**

**AGREEMENT**

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. **INSTRUCTIONS**

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as “All-American Dog/ Mixed Breed.” Sire and Dam information shall remain blank for mixed breed entrants.
